Arrangements for September 2021

On Tuesday 6th July 2021, the Government announced that as part of Step 4 of the roadmap, from September 2021 it is proposing to reduce a number of Covid-19 restrictions, which have been in place in schools for the last 18 months. This decision has been made by the Government to reduce the disruption to children's education – particularly as the clinical risks to children from COVID-19 are low and every adult has been offered a first vaccine and the opportunity for 2 doses by September. The lifting of COVID-19 restrictions in school is in line with the proposed general removal of restrictions in England.

This move is welcomed by REACH2 and our school as the priority is to deliver face-to-face, high quality education for your children. However, we also recognise that it is important that the school continues to play its part in controlling the spread of the virus through protective measures. On the next page, you will find details of the COVID-19 measures which are being removed in September 2021 in schools and those which remain in place following the Department for Education published guidance.

COVID-19 Symptoms

Please note it is imperative that if your child has, or is showing symptoms of COVID-19;

- High temperature
- New, continuous cough
- Loss of, or change to, sense of smell or taste

They must not attend school and should remain at home in line with Stay at Home: guidance for households with possible or confirmed coronavirus (COVID-19) infection – Gov.uk. They should take a PCR test within 2 days and only return to school if the test result is negative. Parents should follow the NHS Test and Trace process. Whilst awaiting the PCR result, your child should continue to self-isolate.

If the PCR test is taken within 2 days of a positive lateral flow test, and is negative, it overrides the self-test LFD test and your child can return to school, as long as they don't have COVID-19 symptoms.

Children who are identified as a close contact of someone who tests positive for COVID.

From the **16th August**, children and those members of staff who are fully vaccinated will not be required to isolate if they are identified as a close contact. Instead, they will be advised to take a PCR test. They will not be required to isolate whilst they await the results of the PCR test.

Please note that self-isolation will continue for those who have tested positive for COVID or who display symptoms.

Protection measures in place in September 2021

School will continue to follow public health advice on testing, self-isolation and managing confirmed cases
Good personal hygiene – regular hand washing/sanitising
Good respiratory hygiene – ‘catch it, bin it, kill it’
Ventilation of all rooms, windows and doors will still need to be opened regularly throughout the day
Regular cleaning regime
Positive cases or anyone with symptoms (high temperature, new continuous cough, loss/change to smell or taste) must not come to school and must self-isolate.
Anyone in school with symptoms, will be sent home.
A PCR test must be taken within 2 days. If the PCR test results in negative, the child/staff member can return to school. If the PCR test result is positive the MUST self-isolate and follow NHS Test and Trace advice.
Close contacts will be identified by NHS Test and Trace. Children and adults who are double vaccinated and are close contacts DO NOT need to self-isolate and can attend school but should take a PCR test.
Remote Education to be provided to all children self-isolating having tested positive. Laptops are available for children so that they can access the remote provision.
FSM will be provided to any child who is eligible for benefits-related free school meals and who is learning at home during term-time due to a positive test result.
No access to school car parks except for Blue Badge holders
Access to school office for appointments and emergencies only

Stepping Measures up or down

An outbreak management plan will be in place, outlining how the school will operate if there were a COVID-19 outbreak in the school or local area (Several confirmed cases within a 14-day period).
Leaders will call the dedicated advice service who will escalate the issue to the local health protection team where necessary and they will advise school leaders should there be any additional action required.

Measures being removed in September 2021

Year group bubbles & social distancing
10 days isolation for close contacts of a confirmed case and adults fully vaccinated
Wearing face coverings in school
Restrictions on school activities including trips (except international), drama, music, Indoor PE, sporting activities and clubs
Staggered starts and ends to the school day
Parents dropping children off at school gate

School routines from September 2021

Breakfast Club starts at 7:40 am – entry via pedestrian gates to school office
Nursery Morning Session starts at 8:30am
Playground gates open at 8:40 am for all year groups
Register at 8:50 am and gates closed
Nursery Morning Session finishes at 11:30 am
Nursery Afternoon Session starts at 12:15pm
Nursery and Reception finish at 3:15pm
Years 1, 2, 3, 4, 5 & 6 all finish at 3:20pm
After School Club: 3:30pm to 4:30pm

Children returning to school on Thursday 2nd September will need to be in full uniform, there will be no PE until week beginning 6th September. Class teachers will be sending out timetables and information for their individual year group by Friday 3rd September.

There will be no need to send in school or book bags until week beginning 6th September.
